- 3. The School has been granted regular Affiliation with the Board w.e.f. 01.04.2019 onwards. Accordingly, the School is eligible to start class IX from the academic session 2019-20 and Ist batch of class X of the school will be appearing at the CBSE Examination to be held in the year 2021.
- The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Secondary School Examination and changes made therein from time to time.
- 5. The school shall appoint only qualified and eligible staff.
- The school will follow the RTE Act, 2009 and instruction issued thereon by the CBSE /Respective State Govt./UT Govt. from time to time.
- 7. The school will help the Board in the smooth conduct of the examination by providing the necessary accommodations i.e. Rooms, Halls, etc. available in the school premises and furniture at its disposal for holding its examinations free of charges if required.
- 8. The school will spare sufficient teachers, for invigilation purpose at the examinations of the Board, as may be required.
